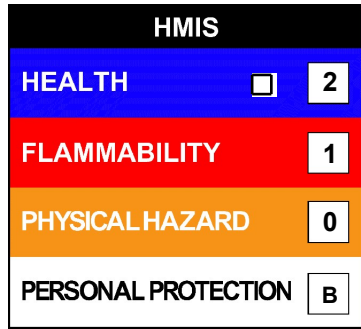
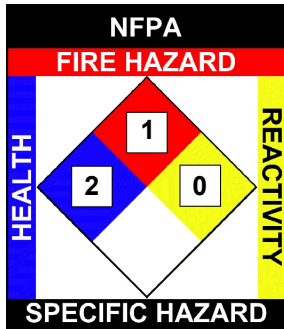

### 4 FIRST AID MEASURES
